A RESOLUTION OF KITSAP TRANSIT BOARD OF COMMISSIONERS AUTHORIZING STAFF TO AWARD CONTRACT KT 25-957 FOR THE MV RICH PASSAGE 1 ENGINE REPLACEMENTS AND REPAIRS PROJECT TO PLATYPUS MARINE INC

WHEREAS, on February 26, 2025, staff publicly advertised Invitation for Bids (IFB) KT 25-957 to replace three (3) engines and complete repairs on the MV Rich Passage1; and

WHEREAS, on March 19, 2025, Kitsap Transit received two (2) bids in response to the solicitation. Platypus Marine Inc was the lowest responsive and responsible bidder in the amount of two hundred seventy-one thousand seven hundred sixty-five dollars (\$271,765); and

WHEREAS, procurement staff has determined the bid pricing received from Platypus Marine Inc to be fair and reasonable; and

WHEREAS, this project was included in the 2025 Operating Budget - Ferry Fund approved via Resolution 24-77 on December 03, 2024.

NOW THEREFORE, BE IT RESOLVED the Board of Commissioners hereby authorizes staff to award contract KT 25-957 to Platypus Marine Inc for the MV Rich Passage 1 Engine Replacements and Repairs Project in the amount of two hundred seventy-one thousand seven hundred sixty-five dollars (\$271,765).

SUBJECT: Recommendation to Award – RP1 Main Engine Replacement and Repairs – KT 25-957

On February 26, 2025, Procurement Staff released an Invitation for Bids; KT 25-957 Rich Passage 1 Main Engine Replacements and Repairs. On March 19th 2025, Kitsap Transit received two (2) bids in response to this solicitation. Platypus Marine Inc was announced as the apparent lowest Bidder pending responsiveness and responsibility checks. Procurement Staff conducted a price analysis comparing Platypus Marine's offered price against our Independent Cost Estimate that was established using engineering estimates and past pricing; the pricing is deemed fair and reasonable.

Procurement Staff has completed the responsiveness and responsibility checks and has deemed Platypus Marine Inc responsive and responsible. It is my recommendation that Platypus Marine Inc be awarded the KT 25-957 Rich Passage 1 Main Engine Replacements and Repairs project in the amount of \$271,765.
